

## **BACKGROUND**

- The Federation of Hong Kong Business Associations Worldwide is a unique network of 43\* Hong Kong Business Associations in 32\* countries with over 13,000\* individual associates. (\*as of December 2018)
- These Hong Kong Business Associations comprise overseas traders, buyers and professionals, who have strong business links with Hong Kong in their respective countries and share the purpose of networking and exchanging of business information and ideas.
- Individual members of these associations are senior business people and SMEs in their home country. They are Hong Kong's close allies and partners in the world.
- With the help of the Hong Kong Trade Development Council (HKTDC), these associations were gathered under an umbrella network - the Federation of Hong Kong Business Associations Worldwide in November 2000.
- The Federation is a non-profit-making entity, incorporated as a limited company in Hong Kong under the Companies Ordinance. Details can be referred to Articles of the Association (AoA).

- To promote global co-operation, communication exchange and synergies among the Hong Kong business associations worldwide;
- To provide a unified global voice that enhances business and investment opportunities in and through Hong Kong.

**LEADERSHIP (OFFICE HOLDERS)** 

• Every three years, members of the Executive Committee elect from amongst the

members a Chairman, Vice Chairman, Honorary Treasurer and Honorary Secretary

among the four regions, the position of which is on a rotation basis.
